1. Introduction

2. Review Minutes d.d. 24th May 2016

- A correction was made on the date of the next meeting to be on June 14th, 2016 instead of May 26, 2016
- Action points 24-05: IOM will resend the Gambella Rapid assessment report

3. Updates:

- a) The ESNFI information management team shared
 - a map and graph of the ES/NFI Cluster responses made in 2016.
 - An overview of the "reporting" of the agencies was shared indicating who did or didn't share information with the cluster.
 - DRC stated that their 1,000 ES/NFI kits reported on the 4Ws in Gambella might not have been distributed and might still be in the warehouse
 - Action point: DRC check if the distribution of the 1,000 kits in Gambella are done
 - Recommendation was made to reflect the needs and gaps with graphs and charts as we
 might be requested to report on such figures either to the gov't or donors

b) Flood response

- The 30.000 in kind DFID NFI kits have arrived in Ethiopia and are stored in Adama warehouse. NDRMC and cluster are coordinating the prioritization, transport, kitting and distribution towards the regions.
- SCI and NRC are preparing the distribution of a total of 12.600 kits to the Somali Region. NRC will apply for additional EHF funds. NDRMC will arrange distribution to the remaining regions, probably with support of WFP Logistics cluster.
- The ES/NFI cluster will monitor the progress and will proactively think about scenario's to support the distributions in Afar, SNNP and Oromia.
- c) Gambella response update
 - ICRC distributed 946 kits to Lare, 207 kits to Gog and 162 kits to Jore in the Gambella region today (14th June, 2016)
- b) AWD, Cholera outbreak Addis Ababa
 - 40 cases were reported on AWD/Cholera outbreak and 11 of them were confirmed. AP:
 Updates will be shared with the Cluster partners.

- c) ES/NFI cluster has informed WHO / Health Cluster that it has stocks (including dignity kits) available when required
- d) Scabies response IOM/UNICEF/WHO
 - IOM, UNICEF & WHO have received funding to respond to scabies affected population. Most
 of the funds for NFI's are still with IOM and goods not yet procured because the need is not
 confirmed and the planning of the WHO and UNICEF response not clear. Distribution of NFI's
 to scabies victims only makes sense in combination with health or hygiene response.
 - It is suggested to wait on the results of the belg assessment
 - ACF shared that it responded to the scabies crisis.
- e) Belg Assessment:
 - Assessment ongoing, ESNFI cluster is actively participating. Results of the assessment per region will be ready end of June.

4. ES/NFI kit specification

- ESNFI cluster proposes to review on the composition / standards of the NFI kits. It can be considered to make adaptations per hazard and region. These standards will be included in the SOP for future responses.
- Cluster therefore establishes an ad hoc TWIG (Technical Working Group) composed of cluster members on a voluntary basis. IRC already volunteered and there is space for others.
- A draft document will be drafted by TWIG and reviews & comments collected accordingly.

Action point: ESNFI cluster team to share a draft document on the type of kits that might be needed for each hazard

5. Combined Procurement & distribution pipeline: SOP

- The ESNFI cluster wants to analyses if combined procurement is interesting for (some) cluster members. ESNFI cluster will collect information about the NFI item specifications, prices and suppliers used by each agency.
- If collective procurement is interesting it will become part of the ESNFI response SOP. This
 document is under development in collaboration with NDRMC. IRC and NRC will actively be
 involved in the development.
- In case procurement by one agency like IOM (which has beneficial customs arrangements) separate MOU would be required between IOM and agencies.
- Action point: each agency to share the prices of NFIs bought so far and from which supplier

6. Information Management

- The cluster IM team requested input / recommendation on their information products.
 - o IM reports should follow the revised definitions of the ES/NFI, including the needs and gaps per region.
 - More information should be collected from the government stocks / distributions

7. Key messages

• More funds required for pre-positioning NFI's.
