## Agenda item 3. Update on recent Cluster Factsheet, 5W

The general factsheet was made for October 2016. The Factsheet is available on the Shelter Cluster website in <a href="English">English</a>, <a href="Ukrainian">Ukrainian</a>, and <a href="Russian">Russian</a>. It includes information on:

- The situation on winterization
- Lessons learned on energy efficiency as a long-term winterization solution through NRC's core house
- ADRA's Canadian Cash for Shelter project
- Re-activation of the Technical Working Group on permanent housing (TWG)

Shelter Cluster Coordinator brought to the attention of the audience information about the next Technical Group on permanent housing planned for December 16, 2016 noting that an invitation will be sent later. Precisions post meeting- Due to low attendance with the start of the holiday season, this meeting has been postponed until January 2017.

USAid\OFDA – The representative of OFDA expressed her interest for her development colleagues to become involved in this technical working group and requested the Shelter Cluster to send updates from the last meeting and the latest available information. She will share their contact details, so they can join the mailing list for this working group.

Shelter Cluster updated the 5W for October. Last week, for all Shelter Cluster partners a reminder about transferring information for the next 5W update was sent. Shelter Cluster Coordinator emphasized the need for timely reporting of 5W that allows to fill other databases and coordinate efforts.

The updating of the names of cities and villages is postponed for the next reporting year. This led to some problems with reporting of 5W, because partners cannot find some settlements, because they have been renamed. Angelina and Kostya in the interim period will help partners to find out in which way to find out how to find these settlements. Partners are therefore encouraged to provide the names of the villages that they are unable to find, and the shelter cluster team will assist in adding them to the 5W.

#### Agenda item 4. Updates on Winterization

Subnational coordinator made an overview of the current situation regarding projects on winterization assistance. An interactive dashboard regarding settlements and assistance provided by the partners in government controlled areas of Ukraine was presented. You can see the database by clicking on the following link <a href="http://www.sheltercluster.org/GCAwinterization">http://www.sheltercluster.org/GCAwinterization</a>. It is indicated that information on the following assistance has already been included in the database:

- Individual means of heat conservation (in cash and in kind) 8089 households
- Means for space insulation (in cash and in kind) 949 households;
- Support for municipal infrastructure 471 households;
- Assistance in fuel for heating (in cash and in kind) 9656 households.

Danish Refugee Council (DRC) – In order to improve the coordination, preparation of new programs and analysis of non-covered needs, it is recommended to include in the interactive dashboard the possibility to track assistance provided in previous winterization support and the results of the distribution monitoring.

Subnational Coordinator stated that generally it is possible, because information submitted by partners includes it, and it is not currently labelled for easier navigation and resources use.

USAid \ OFDA - how often the information in the database is updated?

Subnational Coordinator stated that currently the information is being updated weekly. Additionally, the cross supplementing of database is applied if the information submitted by partners in 5W is present, in order to reduce the burden on the partners regarding reporting.



# Agenda item 5. Summary of the discussions held during the meeting of the Technical Working Group on the Permanent Housing

During the meeting of the group a number of issues related to providing of social housing was discussed. In Ukraine Social housing is a generic term that applies to rental housing that can be privatized or be under the control of the state, non-profit organizations, private sector, or combination of the three, usually in order to provide affordable housing. Social housing can also be seen as potential means from housing inequality. Additionally, it was noted that in various countries under the term "social housing" different things are meant, including how and by whom it is controlled.

Shelter Cluster Coordinator also reported on the meeting held at the Ministry of temporarily occupied territories (MinTOT), which examined the issue of providing social housing for IDPs, as well as model of compensation of lost housing. Currently, the



Ministry of TOT is considering the number of models of compensation (providing new apartment and monetary compensation for the purchase of apartment). It should be understood that this is compensation exactly, and it does not eliminate the need for social housing.

Shelter Cluster is preparing an open library for synthesis and assistance to partners in development programs in this area. The library has several examples of solving such problems in terms of other countries, it is divided by the following areas: 1) Engineering Component 2) Legal component 3) The social component.

USAid \ OFDA representative recommended incorporating in the programs access to livelihood opportunities.

DRC - important components of these programs should be:



- Ability of IDPs to integrate in the new environment. A social element must be included as well, because there is a rather long queue for social housing in Ukraine that existed before the conflict. So providing the appropriate number of new residential places should be widely discussed and agreed with the host communities.
- There is still work on updating the scale of vulnerability for these programs. That should cover all segments of the population that are in need of social housing.
- Programs should provide several options for assistance in order so that IDPs or other vulnerable sections of the population were able to choose a program that best fits their life situation.
- Completion of projects, their transfer to the management of third companies, or State, must be decided and worked out before the active phase of the project. That should help stabilize the situation as soon as possible and will not increase the trend to "according to the Organization".

#### Agenda item 6. Final HNO/HRP in Shelter/NFI sector

Shelter Cluster Coordinator told the audience about the end of targeting HNO and HRP in the Shelter/NFI sector that will be communicated to participants.

Cluster Coordinator also reported the targeting completion of the final indicators on the results of the Shelter/NFI Cluster work.

USAid \ OFDA - How many people still need help on the contact line of GCA and NGCA

Cluster Coordinator mentioned that more than 2,000 households are in need of assistance, in addition in the majority it does not include small fractures (ex. broken window or cleavage in the wall) that are usually available in the list of devastations submitted by local authorities. This is due to the fact that the lists of local authorities include all the destructions, because it is the basis for obtaining compensation in the future.

USAid \ OFDA — the more detailed work is offered in order to work out issues on key terms such as "long-term housing" and how the approach to this type of programs should change depending on their area of application. For example, if there should be the difference between programs along the contact line of GCA and NGCA and GCA in general?

Cluster Coordinator stated that it is actually quite a complex issue and it should be discussed at a higher level. Therefore, he proposed to include it to the issue of the agenda of the Technical Working Group on permanent housing on the basis of long-term solutions, that will take place on December 16.
