- April We are seeing protection issues for those leaving evacuation centers but not yet able to shelter. What is strategy?
 - Look at what shelter interventions would be, possibility of tents, flexibility of cash & vouchers
- HLP issues are there and will have to be addressed. The support will be there for the process of sheltering, its just a matter of how far it will be appropriate by humanitarian actors to assist
- Question of where humanitarian actors role is in response, that its been suggested from government to focus on informal settlements.
- Vula Government is focusing on emergency shelter needs of people during this
 emergency phase, especially those leaving evacuation centers. The focus is on tents
 amongst other emergency shelter and NFI, onto the red zones. This will remain in
 effect during the emergency phase and whats been done will be reviewed afterwards,
 to see how to move forward.
- George Can we know what is happening to address other sectoral needs such as health and food?
 - OCHA yes thru 3ws and reporting

Shelter and Evacuation Centers

- Need to have EC working group housed under gov ministry, and needs to be both inter-governmental and inter-agency to avoid double displacement, creating more ad hoc evac centers. Need to especially collaborate shelter to ensure we can address sheltering needs
- Assessment is needed to understand needs, barriers to returning DTM this week
- Need for IM and IM focal points to manage this
- Displacement Tracking Matrix or Evacuation Tracking and Monitoring. Looks at needs and vulnerabilities of those in EC, and how to address them so people can return to their place of origin
- ETM ongoing now and information, once validated and approved, to be shared with partners.
- What might be obstacles to returning?
 - Usually here, in Pacific context, its shelter kits
- How are people leaving?
 - Some leave on their own, sometimes with help
 - Through key informants we can identify many displaced people
- In natural disasters some people have moved to Suva, we want to know what happened on islands that are effectively catastrophically damaged
- What is happening with teachers quarters
- April Look to coordinate assessments more and add in gender & protection aspects
- Assessments can continue to come in, can be discussed at ICCG.
- Unsure where ECWG will sit, who will lead. Have to raise up through shelter cluster
- Logistics update there shelter stock in pipeline, some left through IOM, Shelterbox, Red Cross, Caritas but not sigficant stock really coming in through humanitarian actors. Chinese government will be donating 6k tents.
- Log Cluster tracks hum actors not gov, that's ndmo

Informal settlements

- pcn has been mapping out informal settlements, 240 settlements, 150k-250k people
- ¹/₄ to 1/6 population of fiji in settlements
- investigating why people are in informal settlements
- what is an informal settlement?
 - o don't have title or lease
 - o includes native, state and private land
- hfh sometimes donors ask on security of investment for interventions in settlements?



- depends on type of intervention
- o might be fear of insecurity, but maybe mostly doesn't match reality
- o there is some security on community-leased state land
- hfh Our process includes agreement to build in these areas, agreement that owner owned the land, agreement with owner and partner, family, etc for a bit of security
- Opinion is that its different working in settlements, need different approach
- There are estimates of potentially 3k hh affected in settlements by cyclone winston, PCN available to consult
- gov requests these mapping to be verified by NDMO, and encouragement that everyone welcome to work here in support of the relief
- 2013 code rights to housing and sanitation offers some protection to people and their housing, only court can decide to expel people from their homes.
- Some settlements are in disaster prone areas
- Gov there has been effort to resettle those squatting, over 10yr process, without procedure in place. adivse partners to approach carefully and with close government coordination.

- care 2 different kits 4000hh northern and western. tools nails and lamp
- comm based and drr. looking to partner with agencies for more long term natural resources managmenet 2000 households
- eu rough assessment carried out by Bernard. 1m euros. work with local partners. 10m Fijian dollars to support recovering, primarily ag, butshelter and other sectors. with spc. falls in under echo framework. adra
- caritas 1000 shelter kit 2 tarps per family plus tool kit. plus wash components
