With ongoing conflict in the area residents of Rubkona County and others remain within the UNMISS PoC seeking safety and access to assistance. Due to heavy rains and low lying areas, the UNMISS PoC has seen a significant amount of flooding affecting some 60-70% of the camp. The current situation poses a threat to all residents wether deemed "vulnerable" or not. IDPs continue to build make-shift dykes but having only soil at their disposal, these dykes fail.

All residents of the PoC are in need of protection from flooding for their shelters. These shelters are primarily made with local wood as well as bamboo and plastic sheeting provided by the cluster. It has been found that most shelters contain two or three registered HHs, many of them are predominantly women and children. In this case it is impossi ble for IDPs to access sandbags locally. All HHs have been served with other NFIs, however in the coming weeks they will need replenishment. Sandbags will provide a quick and easy solution for flooding of HHs and have been specifically requested from community members and leadership.

Most of this assessment has been done simply by visually checking shelters and confirming the extent of flooding. Also, inspecting dykes being made by the community themselves and being requested to provide sand bags to strengthen these dykes.

<b>Define targeting criteria</b> -need/vulnerability (if vulnerability, define vulnerability categories)	All HHs within the PoC should be targeted for assistance.
Specify items to be distributed -Number and type per household - NFI/ES, full kits, loose items -Specify if quantity of items distributed will vary by household size	It is recommended that 15 sand bags be distributed to each HH. Some HHs are sharing shelters so this number of 15 will surely cover larger shelters as well.
Key considerations for distribution -Eg access, logistics, security and protection concerns, push/pull, stakeholders/partners to work with	Sand bags needs to be filled with soil or sand, in this case Concern is already providing large quantities of soil for the IDPs to access. IDPs need to be informed of this soil access and encouraged to use the sand bags for this purpose.
