- CHILD PROTECTION: SCI – all CP activities on going, no reported concerns raised.

- CHILD PROTECTION: SCI child protection activities on going as usual. CFSs all running according to schedule and no concerns raised to camp management.

**4 - Phwe Yar Gone Village** (estimated 2,400 residents)

- WASH: Villagers request WASH assistance: hand pumps, fly-proof latrines and hygiene promotion/health education. Currently there are no latrines in the village and 5 hand dug wells as a source of water.
- PROTECTION: Regular protection monitoring ongoing.

DRC now covering WASH in Pwe Yar Gone village with ECHO funding from July 14 on. Activities will start soon.

**5 - Pa Lin Pyin Muslim Village** (estimated 1,400 residents)

**Issue**

- WASH: DRC conducted regular WASH activities and distributed Ceramic Filters.
- EDUCATION: TLS is run by SCI. Parents & Teachers Association received funds for TLS materials this month.
- PROTECTION: Regular protection monitoring and support to women's group ongoing.
- LIVELIHOODS: DRC business grant activities for Female Headed Households ongoing
- No other updates.

**6 - Pa Lin Pyin Rakhine Village** (estimated 1,300 residents)

**Issue**

- SECURITY: Reports of fishermen from a nearby Muslim village facing problems at the check-point near PLP-Rakhine village.
- WASH: DRC conducted regular WASH activities and distributed Ceramic Filters.
- HEALTH: Mobile clinic comes regularly one time per week (every Tuesday). Two persons are receiving treatment at Sittwe Hospital for malaria and dengue.
- FOOD: All HHs received 4.5kg of rice per person distributed by State Govt authorities (donor/origin of rice unclear). A local NGO "Myat Cetana" distributed around 1-week worth of food supplies to all HHs on 21 July (rice, beans, oil, chilli, salt, onion, garlic, potatoes).
- PROTECTION: Regular protection monitoring and support to women's group ongoing. Generator-powered electricity (as part of community protection assistance) is available to all villagers and functioning well. Damaged sand dam has been repaired by the villagers.
- LIVELIHOODS: In June, ICRC provided fertilizer and paddy seed to the farmers in the village. LIVELIHOODS: DRC business grant activities for Female Headed Households ongoing
- INFRASTRUCTURE: A local company (Su Htoo San) is doing an assessment to prepare for the construction of a cyclone shelter with support from RSG. The exact timeframe of the planned project has not been confirmed yet.

**7 - Ohn Taw Gyi North IDP Camp** (estimated 13,000 residents)

**Issue**

- CAMP MANAGEMENT: Full range of activities on-going, focus on Access to service monitoring and referral, Field Staff training, "library days" for men and women in communal areas, site mapping, updating address system in the camp, integration of

camp representatives into camp coordination meetings Due to Eid restricted hours for camp management offices due to field staff leave, DRC CCCM phone number communicated.

- SHELTER: Major Roofing repairs completed. Additional renovations of shelters struck by storms. IDPs very concerned regarding leaks caused by small holes in roofs. A significant number of shelters still reported to be occupied by the host community who "sell" them to the IDPs, prices ranging 20,000-50,000 MMK. IDPs find it difficult to afford such prices.
- WASH: SCI running full range of Activities – Focus on – Desludging, camp cleaning, planning for concrete drainage, formulation of WASH committee, Hygiene promotion and repairs and replacements of water points. Some concerns raised about accessing latrines on north side of camp due to paddy fields in the rainy season.
- HEALTH: Mercy Malaysia / MHAA clinic opened, however IDPs report non regular schedule and closed for entire week 5 of July. IDPs report rural health centre not open regularly and mainly used for vaccinations not general health.
- FOOD: WFP caseload distributed by CDN. IDPs request distribution schedule. MRF caseload distributed, IDPs raised concerns over regularity of MRF distributions. Government (section unknown) reported to have delivered 97 rice bags to OTG 6, Yangon based private donor donated a number of food items to religious leaders, MAUK delivered 10 items of food to CMC for camp residents, IDPs raised concerns regarding receipt of these items.
- EDUCATION: LWF – education activities ongoing (closed for Eid) focus on – schooling, distribution of kits. UNICEF - Some concerns raised over salaries for Teachers and distribution of kits in OTG 1. LWF to take over all education activities in August for OTG North.
- NON-FOOD ITEM: IDPS raised the need for Kitchen Utensils & Mosquito nets, clothes and blankets, solar lanterns and firewood.
- PROTECTION: Regular protection monitoring, IPA, and support to women's group ongoing. Psychosocial support & personal growth training for the women's group completed. Camp lighting is consistently reported by women as a protection need. IDP women reported concerns that male and female IDP leaders are attempting to collect money from (potential) IPA beneficiaries.
- NUTRITION: MHAA, ACF and SCI offering Nutrition services. Main focus – Referrals, assessment of malnutrition. Concerns raised by camp residents that after referral, couldn't access healthcare due to Health clinic closures.
- CHILD PROTECTION: SCI and LWF CFSs opened regularly, DRC completed community mapping, focus group discussions with Youths and renovation works on new CP office (OTG 1).

Health – Concerns referred to Health Cluster.

**8 - Ohn Taw Gyi Village (estimated 2,400 residents)**

- EDUCATION: School extension almost completed by DRC CCCM (QIP).
- HEALTH: Villagers report health concerns of malaria and diarrhoea and having problems accessing clinics.
- PROTECTION: Regular protection monitoring and support to women's group ongoing.
- CHILD PROTECTION: Youth Centre construction in progress (DRC CP).

Health concerns referred to cluster, DRC request to villagers to contact CCCM if any problems accessing clinics. Protection also following up.

**9 - Ohn Taw Gyi West IDP Camp (estimated 3,200 residents)**

**Issue**

- SECURITY: Tensions (non violent) continue between the initial camp residents and the group of IDPs who moved from STMG camp in February 2014 due to security problems.
- CAMP MANAGEMENT: Full range of activities on-going, focus on Access to service monitoring and referral, Field Staff training, planning of sports activities (cane ball matches), site mapping, updating address system in the camp, integration of camp representatives into camp coordination meetings, Special focus communicating with STMG displaced group, who cannot built temporary shelter until they get approval from RSG. Due to Eid restricted hours for camp management offices due to field staff leave, DRC CCCM phone number communicated.
  - Camp lighting was reported among the priority needs, along with firewood and NFIs.
  - Tension between CMC and DRC CCCM related to DRC's support to the group who moved from STMG camp, and a construction contract awarded to an external contractor as opposed to the CMC.
  - SHELTER: Major Roofing repairs completed. IDPs very concerned regarding leaks caused by small holes in roofs.
- WASH: CDN WASH activities ongoing main focus on – camp cleaning, Hygiene kit distribution, updating caseload lists, ORS support, repairing of water stands. Concerns regarding broken latrines in the camp (some caused by recent storms).
- HEALTH: IRC clinic provided healthcare 2 days a week (1 day in week five). Not all patients are able to access the service due to the limited opening hours, so some have to resort to traditional healers because of that, but others are unable to afford it. No serious health concerns reported to CM.
- DEATHS: Two children were reported to have died of high fever.
- FOOD: CDN – Distributed WFP rations (oil split into two distributions), MRF – distributed to their caseload. Three private donors from Yangon, Malaysia and That Kay Pyi donated food and money to Tan Daw Li group. WFP made a meeting with IDPS about rations. IDPs state need more / different variety of foods.
- EDUCATION: SCI regular education activities 9-4 daily (minus during Eid), all TLSs open and functioning well, IDPS and teachers request student kits. One private donor supplied 500mmk per student.
- NON-FOOD ITEM: No Update on NFIs. One private donor gave one suit for each child in the Than Daw Li group.
- PROTECTION: Regular protection monitoring, IPA, and support to women's group ongoing. Preparation for psychosocial support training for the women's group. Women's Center to be renovated in August (DRC Protection).
- NUTRITION: No set Nutrition partner offering full services in OTC. ACF visiting to provide some nutrition activities. No major concerns raised to CM.

**Status**

- Re STMG Group DRC have been in contact with the TA repeatedly, meeting on Monday to hopefully get approval letter, and will then distribute materials for temp shelter.  
 DRC – will distribute “Metal tape” to all shelters in August, to be used by HH to repair minor holes in roofing not requiring replacement.

WASH – Reported concerns of latrines to CDN.

Food – concerns regarding many food providers / possible gaps / overlaps forwarded to food sector. WFP advise for August cannot provide Schedule due to logistical constraints of deliveries – requested this be communicated to camps by WFP – Awaiting response.

- CHILD PROTECTION: DRC setting up program, meeting CMC, setting up CP office, camp mapping, Focus group discussions. UNICEF visited camp for CP monitoring.

**10 - Ohn Taw Chay Village**

- PROTECTION: Regular protection monitoring and support to women's group ongoing.
- CHILD PROTECTION: Youth Center construction ongoing (DRC CP).
- LIVELIHOODS: DRC business grant activities for Female Headed Households ongoing

**11 - Baw Du Pha IDP Camps (estimated 11,000 residents)**

- SECURITY: BDP 2 camp - In week 4 - disturbance between the committees /VA and IDPs. After confusion with a misdirected truck for distribution to another camp, delays in NFI distribution, and following from prior concerns regarding assistance and lack of livelihoods in the camp, IDPs thought that some assistance was being exploited by the committees and sometimes the committees asked for money from the agencies. In response to this perception, reportedly, an angry mob marched to the administrator's house and broke the fencing and windows down and went into the house and took away some money and gold. According to community based information, some 10 people involved in the mobilising of the group were arrested by the police, a full understanding of the situation is still unclear, so no confirmation of reports identified as of yet.
- CAMP MANAGEMENT: Full range of activities on-going, focus on visiting camp to talk to concerned residents after security incident, finding space for CMO, camp coordination meeting, Access to service monitoring and referral, Field Staff training, planning of sports activities (cane ball matches / football), construction of warehouse for food and football pitch, site mapping, updating HH survey information, integration of camp representatives into camp coordination meetings, Due to Eid restricted hours for constant presence, due to field staff leave, DRC CCCM phone number communicated.
  - SHELTER: Major Roofing repairs completed. Additional renovations of shelters struck by storms. IDPs very concerned regarding leaks caused by small holes in roofs.
- WASH: SI running full WASH activities in camp – main focus on – monitoring of hardware, camp cleaning, hygiene kit distribution, renovating latrines, drainage, monitoring of health concerns. Major activities suspended for Eid. Destruction to WASH activities by camp residents reported, particularly damage made to hardware.
- HEALTH: Mercy Malaysia Clinic offering healthcare service – scheduled to open 3 days per week, opened once in weeks 2 & 4 and was closed in week 5. Camp residents expressed concern over opening hours and lack of communication. Also concerns by camp population of type of treatment given.
- FOOD: WFP distribution of caseload in week 2 (minus oil), oil distributed in week 3 for 15 days. MRF distribution in week 5. Private Yangon based donor supplied a food basket of 6 items to 155 HH not on the WFP caseload.
- EDUCATION: SCI – TLSs running normally (minus week five for Eid). Many concerns raised re student kits – reported Government delivered in week 4, but distribution delayed due to Eid.
- NON-FOOD ITEM: No NFI distribution taken place in BDP camp. Please also refer to Security – NFIs high concern.

**Status**

DRC – following up concerns re CMC – IDP relations. Requested all agencies to be transparent of distribution schedule and methodologies, plans upcoming for conflict resolution training for CMC. Concerns regarding livelihood are being followed up at Sittwe level.

DRC – will distribute “Metal tape” to all shelters in August, to be used by HH to repair minor holes in roofing not requiring replacement.

WASH – concerns seem to be linked to CMC and livelihood issues. CM to follow up with Livelihood sector and CMC. Camp wide sensitization may be needed re damaging camp infrastructure and consequences. Health concerns referred to health cluster. re treatment – possible need for sensitisation. Food - WFP advise for August cannot provide Schedule due to logistical constraints of deliveries – requested this be communicated to camps by

- PROTECTION: Regular protection monitoring, IPA, and support to women's group ongoing. Due to security situation and inaccurate report of DRC's involvement (see above) DRC Protection activities were suspended between 23-31 July due to sensitivity; UNHCR Protection stepped in. Preparation for psychosocial support training for the women's group.
- NUTRITION: SCI and ACF & MHAA offering regular programming. Some suspension of some activities during week five for Eid. SCI nutrition centre damaged in storms.
- CHILD PROTECTION: SCI – all CFSs open and running smoothly. No further update. No CP concerns raised to CM.
- LIVELIHOODS: Women's group requested sewing training for women and adolescent girls in the camp.

WFP – Awaiting response.  
DRC – Planning NFI distribution 3<sup>rd</sup> week August and will communicate fully in advance with camp community **and** leadership, and authorities.

**12 - Baw Du Pha Village (estimated 11,000 residents)**

- SECURITY: Village Administrator's house attacked by a mob of IDPs; house damaged, some items stolen. See details above under SECURITY for BDP camp.

- CHILD PROTECTION: SCI running CP activities –CFSs open and running normally. No CP concerns raised to CM.

**14 - Dar Paing Village**

- EDUCATION: Villagers advise Indian Donor building school in the village.
- SHELTER/HOUSING: MRF visited with international donors re possible rebuilding houses damaged in Fire.
- INFRASTRUCTURE: DRC distributed Solar panels to Female HH and HH affected by fire. (QIP), training and monitoring ongoing.

**15 - Zaw Bu Gyar Village (estimated 340 residents)**

**25 - Kyein Ni Pyin IDP Camp (estimated 4,500 residents)**

- **CAMP MANAGEMENT:** IDPs informally agreed to set up a committee for collecting 10% of the salaries of all IDPs who work, to be used as a fund for camp maintenance, social occasions (celebrations, funerals), and for support to IDPs with no income. They are waiting for the developments in other camps (particularly ANY).  
**SHELTER:** No updates re: reported damage of an unspecified number of shelters.
- **WASH:** IDPs would like to get a cash for work contract for pond renovation (initiated by the IDPs themselves, but temporarily suspended). DRC conducted regular WASH activities in KNP. Monthly replenishments for June and July distributed.
- **HEALTH:** MoH mobile clinic arrived one time per week during July, opening hours not sufficient to attend to all patients. IDPs report dissatisfaction with medical services.
- **FOOD:** July ration distributed during the first week of July.
- **EDUCATION:** No updates.
- **NON-FOOD ITEM:** ICRC delivered firewood for all HH.
- **PROTECTION:** Regular protection monitoring, IPA, and support to women's group ongoing. Complaints from IDPs who are not receiving IPAs - need awareness-raising campaign on PwSNs and IPA criteria, as well as a Complaints Response Mechanism.
- **NUTRITION:** Regular activities ongoing.
- **CHILD PROTECTION:** Regular activities ongoing.

**26 - Kyauk Pyin Seik Village (estimated 575 residents)**

- **EDUCATION:** A post-renovation school opening ceremony was organized by DRC (as part of community protection assistance) with participation from SCI, who also provided student kits and other materials. The ceremony was attended the villagers, including the VA, and by the Deputy TA and Deputy Education Officer.
- **PROTECTION:** Regular protection monitoring and support to women's group ongoing.
