# CCCM/Shelter/NFIs Sub Cluster Meeting Held on 20 August 2014 in UNHCR Conference Hall

## **Opening remarks**

The chair welcomed and thanked participants for the usual meaningful contribution and partners as well introduced themselves.

### Review and adoption of previous meeting minutes

Minutes of the previous meeting was reviewed and adopted as official meeting minutes except for one pending issue due to the absence of UNICEF and Alkhair and it has been brought-forth to the next meeting.

#### **Updates by Agencies**

### a) CCCM

- Food distribution for the month of August for Camps I & III took place on 17<sup>th</sup> and 18<sup>th</sup> August with no issue to report. All families received their rations except 150 families who are reported to have left the camps sometimes ago. The registration taskforce is currently carrying out verification on them and the result will inform WFP's decision vis-à-vis quantity to be received by the individual families. A tent got burnt involving a child who suffered from first degree burnt and has received appropriate medical attention.
- ExU is temporarily managing water supply for the camps after NGO running the water project abandoned the project due to what it called continuous increased in fuel cost and pointless problems from the beneficiaries (IDPs and hosts).
- Islamic Relief is conducting a three day human rights workshop targeting service providers in the camps.

#### b) Shelter

- Yemen Family Care Association (YFCA) presented to the forum its new ERF funded project which include the construction of 170 transitional shelters units for IDPs from Al Mazrak camp opting local integration. The project is expected to include 20% of most vulnerable from the host community. Meanwhile, YFCA is awaiting approval of the new shelter design recommended by the sub cluster to embark on the project but voiced that any delay will affect the project implementation period. And the project will include individual family latrine and all levels the beneficiaries remain at the core.
- NRC informed that it has completed repair work on the 87 transitional shelters affected by the rainstorm in Hayran District in May with funding from UNHCR. Also NRC said it is finalizing identification of 200 beneficiaries for the DFID funded transitional shelter project scheduled to commence in the last week of August. The latter project will target 70% IDPs and 30% hosts as recommended by the donor according to NRC.
- VHI presented a new project proposal to the sub cluster forum and solicited comments and as well as views on the project. According to VHI, the project is targeting 270 beneficiaries (80% IDPs and 20% hosts) with transitional shelters. The project is intended for IDPs who have spontaneously

returned to their places of origin in Mustaba and Khayran Al Muharraq Districts. As indicated by VHI, the project will involve beneficiaries at all levels including cash for work opportunity during the shelter construction activities. The shelter will include family latrine and solar lighting for every unit. The sub cluster made a general consensus on the project adding that families who already benefited from VHI previous shelter project in the displacement areas should not be targeted. Also VHI was advised to use ExU database to identify the beneficiaries, use the agreed shelter design for the northern region and allocate 20% of the project to the most vulnerable locals in the project sites.

## c) NFIs

CSSW informed that next week it will commence distribution of Core Relief Items (CRIs) funded by ERF in Khayran Al Muharraq, Bani Qais, Ku'aydinah, Aslem, Mustaba and some areas in Haradh. The CRIs package includes the following mattresses, blankets, kitchen sets, sleeping mats, jerry cans, buckets and plastic sheets targeting 1,998 families based on ExU database.

## **Action points**

- UNHCR Haradh to call CCCM/Shelter/NFI Cluster Coordinator to get update on the newly recommended shelter design by the sub cluster in order for YFCA to commence implementation of the project in the Al Mazrak area.
- UNHCR Haradh to re-share minutes of the *ad-hoc* Shelter Design Review meeting with the cluster members.
- VHI to request from ExU list of IDPs being targeted by their new project proposal.
- UNHCR Haradh to call for ad-hoc meeting among OCHA, VHI, CSSW and ExU to discuss and address potential duplication in CRIs distribution about to take place between CSSW and VHI in Mustaba, Khayran Al Muharraq & Hayran districts.
- YFCA to share, if any, with cluster members assessment report for their ERF project which targets families opting for local integration from Al Mazrak camps.

#### **AOB**

UNHCR updated the forum that a Technical workshop on durable solution was held on 6<sup>th</sup> August with representatives from all stake holders including Ansar Allah (Al Houthies' political branch), Executive Unit, Local Authorities of Haradh, IDPs (male and female), UN agencies (WFP, UNICEF, UNDP, OCHA, WHO, UNHCR) and the NGO forum. And at the meeting a general consensus was reached to focus on return as durable solution for the IDPs in Al Mazrak Camps (I&III).
