### JIPS OVERVIEW

#### **PROFILING IDP SITUATIONS?**

- Collaborative process aimed at consensus and informing joint response
  - Data collection or 'evidence-generation' exercise to better understand displacement situations
  - Adaptable approach in terms of specific objectives and methods

# PROFILING SUPPORT

- Technical support service
- Building consensus (between government, humanitarian and development actors)
- Interventions respond to field requests
- Support to advocacy, planning, methodology and tools design, data collection, training, data analysis and reporting



#### **Profiling "for Durable Solutions"**

- Relevance of profiling
- On-going project led by UN Special Rapporteur for the human rights of IDPs and JIPS
- IASC Framework definition, principles and criteria as conceptual basis for project
- Technical Steering Committee and field testing process as cornerstone of project





"...no longer have any specific assistance and protection needs that are linked to their displacement and can enjoy their human rights without discrimination on account of their displacement"

#### **MISSION & BACKGROUND**

- Request for support from Ukraine in May 2016
- Discussions to broaden scope from 'housing solutions' to 'durable solutions'
- Initial/short scoping mission
- Partner meetings: R2P, IOM, WB, Shelter Cluster, Protection Cluster, UNHCR, GIZ, HelpAge, PIN, REACH
- Two Kiev Collective Centre visits



#### **GENERAL OBSERVATIONS**

- New IDP Ministry, limited capacities; different ministries with IDP responsibilities
- Transitional nature of operation
- Two displacement contexts (Crimea and Donbas)
- State-led humanitarian response (registration, social support)
- Unclear IDP definition and definition of Collective Centres
- Registration and IDP status
- Multiple data/information sources on displacement
- Strong capacity of the humanitarian community

> Individuals living in collective centres

- Social cohesion
- Information on social benefits
- Perception/threats of eviction


#### **PROPOSED OBJECTIVES**

To understand the situation of IDP households residing in Collective Centres to identify possible durable solutions

To inform response in support of IDPs in prioritized Collective Centres to help find sustainable alternatives

To develop a national strategy in face of increasing risk of Collective Centre closures including capacity building element

#### METHODOLOGY

Steps and methods	Details	
THEMES AND INDICATORS IDENTIFICATION	Typologies of CC, definitions of target population, prioritized durable solutions indicators, etc.	
DESK REVIEW	Review of existing data, possible baseline data and information, themes already covered in previous surveys on collective centers, etc.	
KEY INFORMANT INTERVIEWS & UPDATE OF COLLECTIVE CENTRES DATABASE	Update of the collective centers database collecting additional information on the centers (infrastructures, service, etc.) Done face to face by the data collection team.	
PRIORITY SELECTION OF THE COLLECTIVE CENTRES	Identify criteria and target relevant CC	
HOUSEHOLD SURVEY	Full coverage of the selected collective centers with household surveys.	
TARGETED FGDs DEPENDING ON INDICATORS AND GAPS	Focus group discussions with relevant population (elderlies, youth population, displaced groups, etc.)	
INTERVIEWS WITH LOCAL AUTHORITIES	Interviews with local authorities responsible for the collective centers/displaced population.

## **PROPOSED OBJECTIVES**

Comprehensive profiling of displacement situation to inform solutions strategy in the Ukraine, through building consensus on:

- Comparative analysis of different groups (registered IDPs, unregistered IDPs, Crimean IDPs, and host communities)
- Better understanding of displacement situation through vulnerabilities, coping mechanisms, intentions and capacities, as well as needs of target groups
- Using the IASC framework for durable solutions as a lens for analysis, including key elements on social cohesion, discrimination and participation in public affairs
