Action Points

1. *NDRMC requested IOM to do a stock count of the supplies.*
2. *ES-NFI cluster and NDRMC look for additional “bodies” for kitting and loading*
3. *NRC to send funding proposal to EHF*
4. *NDRMC to propose allocation to final distribution points in Afar, SNNP and Oromia*
5. *ES-NFI will send specification of the items to WFP.*
6. *NDRMC to allocate the 4,400 extra shelter kits and the supplementary items*

Meeting was called to resolve pending issues concerning the transport and distribution of the ES NFI kits donated by DFID that arrived in Adama warehouse. **AP:** *NDRMC requested IOM to do a stock count of the supplies.*

WFP – Logistics cluster mentions that new food supplies are coming in to Adama and that the space occupied by the DFID kits is urgently needed to be able to receive those.

WFP expanded the storage capacity recently and indicated that there is space in Adama warehouse to do kitting but that additional labour is required. **AP:** *ESNFI cluster and NDRMC look for additional “bodies” for kitting and loading*

The situation for the Somali region and the remaining regions were subsequently discussed:

Somali region:

The Prioritized needs of 12.461 kits, requested in a letter by the DPPB Somali region to NDRMC were approved by NDRMC.

Save the Children (SCI) has committed to “kit”, transport and distribute at own expense a maximum of 9.400 kits to the Shebelle and Korahe area’s. Currently only 4.023 kits are prioritized by DPPB Somali region for these areas, so it is possible to allocate more. (SCI started loading the first kits directly after the meeting).

Norwegian Refugee Council (NRC) is prepared to “kit”, transport and distribute 8.284 kits to the Sitti, Faafan and Nogoh area’s but do not have sufficient own funding for this. Therefore they request additional funding from the EHF. Because EHF fund request and release normally takes some weeks, OCHA approved that NRC can re-allocate (some of) their current EHF (OCHA) funding (purposed for the procurement of NFI kits) to this operation and to welcome a new funding request. **AP:** *NRC to send funding proposal to EHF*

Afar, SNNP and Oromia regions

NDRMC has yet to finalize the field distribution points in these regions and therefore plans that dispatch initially to regional warehouses. DFID reiterated that these Kits were flown in to cover urgent needs and not for stockpiling. **AP:** *NDRMC to propose allocation to final distribution points*

WFP – Log cluster can arrange transportation to the regional hubs in Afar, SNNP and Oromia regions and to the final delivery points. It has to hire additional truck and therefore needs detailed information about the regional (and where possible area / site) allocation, items sizes, tonnage and packaging of all items. **AP:** *ESNFI will send specification of the items to WFP.*

EHF is willing to cover the costs of this service, where WFP is pre-financing this operation not to delay things. Indicative price is US \$ 70 per MT.

Kit Composition (added to these notes for clarification)

- The total DFID consignment consists of five ‘core items’: 60.000 thermal blankets, 30.000 kitchen set, 34.400 shelter kit, 30.000 14 liter bucket, 30.000 sleeping mat
- and two ‘supplementary items’: 1.500 cleanliness kit and 1.980 lifesaver cube.

Allocations of Items per Region and Provider

The current itemized regional list reflects only the core items as NDRMC has not shared the distribution plan for the supplementary items (cleanliness kit and lifesaver cube).

The supplementary items are not sufficient to distribute with all kits and represent a small amount in comparison to the overall number and volume of materials.

Additionally, 4,400 extra shelter kits were provided by DFID (in excess of the 30,000 total kits). NDRMC has not shared a plan for the distribution of the excess shelter kits and therefore they are not reflected in the itemized regional lists at this stage. **AP:** *NDRMC to allocation the 4.400 extra shelter kits and the supplementary items*
