Concern	In West Kordofan, Concern WW, with HAC conducted flood assessment and provided NFIs to assist 1500 households. Additional 3,000 NFIs available to assist flood affected populations in BNS, Gezeira, and River Nile state.	
UNAMID	Status of renewal request for 1,300 HH in Kassab camp, ND.	According to ES NFI project, Goal has not yet submitted a renewal request. The office in El Fasher is requested to follow- up.
Islamic Relief	Continues response in Khartoum, distributed NFIs in 3 locations in Eastern Nile for 398 households, and in mayo Area targeting 449 households. Ongoing assessment in Umbadda and eastern Nile, 1000 sets of kits to be distributed.	
Triangle	NFI replenishment for 800 households completed in Um Dukhon, transported by WFP. Waiting for road access to Bindisi to complete the renewal distributions.	
UPO	Operations in south Darfur: Submitted requests for renewal and returnees in Buram and al Radaoum Areas. UPO completed provision of temporary shelters for 54 HH in Buram.	ES/NFI Project office in El Geneina will process the request.
