## NEED ANALYSIS

- IOM's Monthly Internal Displacement Update (MIDU), covering the period between January and September 2016, reported that 588,884 individuals or 107,070 households were newly displaced due to various causes such as drought, flooding, resource-based competition and inter-community clashes.
- Overall, the number of those displaced by flooding accounts for 59% of total new IDPs during this period, the other 31% by flooding and 9% by drought.
- Around 90% of the flood-displaced population returns to their place of origin within a short time frame. However, those who have lost their livestock as well as been displaced by the drought are often without prospect of longer-term solutions.

## RESPONSE

- The cluster received \$12.7 million in 2016, accounting for 52% of the requested \$24.4 million in HRD 2016.
- At the end of 2016, the cluster has reached 62,152 households with emergency shelter material, and just over 30,000 for household Non-Food Items.
- By the end of 2016, the cluster has over 20,000 emergency shelter and NFI kits in stock and pipeline.

## GAPS / CHALLENGES

- Traditionally the cluster's sole response modality is through distribution of emergency shelter material and household items. This year the cluster is working to expand this to address varying need of different displacement context as well as those recurring, cyclical, short-term displacement such as flooding. This is particularly vital in areas where improvement of existing shelters could lead to reduction of displacement in the future.
- Sustainable funding for dedicated coordination team in this complex and protracted situation.
