Partner updates and Action Items from this meeting

Partner	Discussion / Key Points / Actions
<u>2015 and 2016 CERF projects</u>	The CERF ES/NFI project, started in 2016, is completed in Sortony, Kabkabiya Locality and Tawilla Locality, North Darfur. The overall objective of the ES/NFI component of the CERF project was to ensure that some 51,000 people (10,020 households) displaced due to conflict in Sortony and Tawilla identified to be in need of life-saving assistance, receive non-food items and emergency shelter. The CERF contribution allowed the procurement of 11,840 ES/NFI kits in 2015, the ES/NFI sector received funding to serve 71,091 beneficiaries with Shelter materials, in -El Fasher (incl. Zam Zam), Kebkabiya,, Mellit,, Dar Es Salam (shangil tobiya), and Tawilla. The Project was completed and shelter materials were distributed to all beneficiaries.
<u>CHF 2015 and 2014 Reports</u>	Partners almost completed all their pending reports, except a few, who were notified accordingly to submit their final reports. OCHA mentioned that the timely completion of reports will be an advantage for partners to prequalification for further funding windows.
<u>Key Gaps and funding shortage</u>	In 2016 the ES/NFI sector is targeting 700,000 people, the sector responded to 142,185 IDPs with emergency shelter (0.3m) funded, the response were mainly for Darfur 127,100 and in the rest of Sudan states, 15,175 people were assisted. in addition, emergency shelters were provided to 31,450 people. 2015's Carry over stock was used to support 30,000 HHs (150,000 people) during the first quarter, Funds urgently required to procure 45,000 NFI kits to maintain preparedness. This will cover some 220,000 people (40% of the remaining 2016 target of 550,000)
<u>NCA</u>	NCA completed their CHF 2015 second allocation project, 5,114 households assisted in central Darfur, 1500 households were assisted with transitional emergency shelters were Bamboo, wooden poles and grass matts were distributed to beneficiaries. In 2016, NCA served 2,541 households with NFI baskets from the common pipeline. in south Darfur. Regarding 2016 SHF 1 st allocation, NCA received the 1 st instalment and the action plan has commenced already. also NCA has trained 145 community members on NFI distribution, HIV, shelter construction and ERD.
<u>TGH</u>	Early this year, TGH supported 1200 returnee's households in Muraddaf, Um Dafoug locality. TGH received an RRF funding to support the returnees in protracted IDP in um Dafoug locality. TGH distributed 410 shelter materials from the 2015 CHF 2 nd allocation. THG stated that they are waiting for confirmation from UNHCR field office to provide 1,400 households returnees with NFIs from the common pipeline.
<u>UPO</u>	In East Darfur, UPO conducted an assessment for the south Sudanese Refugees, along with UNHCR and SRCS. The assessment was finalized in Matiang, East Darfur but awaiting security permission for Assalaya. In south Darfur, UPO distributed 200 NFI kits to refugee households of CAR, through RMS sector in Umdafog and also provided 200 emergency shelters for the most vulnerable.

	UPO stated that they have an issue with releasing NFIs for Sheria and Yassin localities, and mentioned that they have already submitted an NFI request (800 hh for Sheria and 500 hh for Yassin). Finally, UPO has completed all activities of 2015 CHF 2 nd allocation projects in a handover ceremony in south Darfur.
<u>El Ruhama</u>	In South Darfur, 200 IDP households received emergency shelters in Al Salam locality and 125 IDP were trained on environmental preservance.
<u>IOM</u>	Iom is conducting several verification missions in Habila, initally 30,038 refugees, returnees and IDPs were reported. Another mission is planned to Beltebe and Garraaya in central Darfur In addition to the Returnees verification in Umdukhon.
<u>NCA</u>	NCA provided 674 refugees in Belil, South Darfur, with coordination with CORE. Also 1,634 returnee's households were assisted with NFIs in Rongatas.
<u>AOB</u>	Mr. Abdalla from ECHO attended the meeting, and had some question about the challenges in customs, key gaps and procurement difficulties. NCA, TGH and UPO raised the question of delays in approving NFI requests, saying it takes 40 -60 days for approval
