AlHudaydah hub

Recent Displacement

• 721 HHs / 4,348 people displaced from Al-Khawkhah and Hays districts in AlHudaydah Governorate also some areas in Taizz Governnorate to Jabal Ras, AlJarrahi and Bait AlFakih districts in AlHudaydah Governorate (Source: ExU / ACF (RRM) / Cluster Partners)

Updates:

- UNICEF and UNHCR undertook needs assessment through Jeel Al Bena Association in Aljarrahi and Jabal Ras districts on 27th of December. The key findings revealed the need of 500 IDPs and host community families for NFIs in addition to the need of some families for shelter solutions. The assessment emphasized the need to extend the assistance to the host community. UNHCR participated in a joint humanitarian convey participated by UNICEF and WPF and distributed NFIs to 421 IDP families and 79 families of the host community.
- ACF was alerted by ExU of the displacement of about 300 IDP families in Bait AlFaqih and planned to conduct a rapid needs assessment on Saturday (13/1/2018) if access is granted to verify the displacement figure and provide an overview of the needs. Save the Children confirmed their readiness to undertake the distribution of NFIs, water tanks and Hygiene kits.



Ibb hub

Recent Displacement

- 377 HHs / 2,639 people displaced from AlHudaydah and Taizz to Far Al Udayn, Al Dhihar and Dhi As Sufal districts of Ibb Governorate (Source: Cluster Partners / ExU / Local community)
- 228 HHs / 1,596 people displaced from AlHudaydah and Taizz to Al Mukha district and other sub-districts in At Taiziyah district of Taizz Governorate (Source: Cluster Partners / ExU)

Updates

- In Ibb, UNHCR through their IP ACTED have performed the following:
- 25 HHs were assessed in AlMashanah and AlDhihar districts and distribution of NFIs started on Thursday (11/1/2018)
- 170 HHs were assessed in Far Al Udayn and Dhi Sufal districts and will be provided with NFIs in Sunday (14/1/2018)
 - Assessments in all displacement locations still ongoing.
- In Taizz, IOM have completed an assessment in At Taiziyah district and assessments are ongoing in other districts.



Aden hub

- 150 HHs/ 1,050 people displaced from AlKhawakah district in AlHudaydah Governorate to AlBuraiqa district, Aden Governorate. (Source: Local authorities)
- Latest IOM/DTM ET report shared on 8/1/2018 indicated the displacement of **3,482 HHs** from Al Bayda, Al Hudaydah, AlJawf, Al Mahwit, Amanat Al Asimah, Amran, Dhamar, Hajjah, Ibb, Lahj, Marib, Sana'a, Shabwah, Taizz to the following governorates: (Source: IOM/DTM)

Updates:

- Joint mission participated by OCHA and Shelter/NFI/CCCM, WASH, Child Protection, Protection, Food Security Aden Sub-National Clusters on 2nd of January to assess the situation of 50 IDP families fled toAl-Falaheen Village and Nearby Areas, Ga'walah, Dar Sa'd District, Aden-Governorate from AlHudaydah and Taizz. The key findings revealed the need of the families for NFIS, EESKs, cash for rental subsidies and solar panels/lamps.
- Inter-agency mission carried out by OCHA, IOM and WHO to AlDhale'e on 3rd of January. The mission met with the Governor, AlNasr hospital and the NGO forum established in AlDhalee and host by OXFAM. The recommendation was to cross-check the displacement reported by IOM/DTM and conduct a rapid assessment by Aden Inter-Cluster Working Group. It was also recommended to the Shelter/NFI/CCCM Cluster to review conditions of IDPs in Al Dhale to better understand the request for a camp made by authorities
- UNHCR and the Sub-National Cluster coordinator paid on Thursday (11/1/2017) a visit to two IDPs hosting sites in Fogoom area, Buriaqah district which host 48 HHs.
- 5,361 IDPs families / 37,527 people were assisted in the past two months as a result of the recent displacements to Abyan, Aden, AlDhalee, AlMaharah, Hadramout, Lahj, Shabwah and Taizz Governorates
- 3,355 IDPs families / 23,485 people planned to be assisted by NFIs/EESK kits.

Update on HRP 2018: method, targets and budget

- The number of people targeted increasing from 2.2 million in 2017 to 3 million targeted for assistance in 2018 of whom 2.6 million are in acute needs.
- The methodology for determining the overall target for the Cluster was determined AS follow: 100% of People in need in acute severity locations and 18% in medium severity locations that were captured in 2018 HNO. The calculation of targets for each activity was based on the Cluster overall total targeted beneficiaries, HNO severity indicators, locations with high needs and minimal implementation in 2017, and other sources such as the Cluster database of IDPs Hosting Sites.
- Total Cluster requirement is \$195 million (USD).



Current Workflow




