### Data sources

Primary Data: Key informant interviews in collective centers and spontaneous sites

Secondary Data: 1. List of collective centers and spontaneous sites from CCCM cluster


2. TFPM data – Location of IDP and returnee informal sites

• **Population of interest**: *Displaced population* residing in sites of more than 5 households grouped together, where assistance and protection services can be directed collectively, across 22 governorates

#### **Progress so far:**


- 4 Governorates assessed and analysis being completed, 6 Partners providing Site Management and Site support services. Guidelines completed, ExU trained
- IOM completed in 660 Sites in 10 Governorates Taizz, Lahj, Ibb, Aden, Al Dhale, Abyan, Shabwah, Hadramaut, Socotra, and Al Mahara. 2 Ongoing in Al Jawaf and Al Bayda
- 6 Governorates (Sa'ada, Hudaydah, Hajjah, Rayman, Sana'a and Al Mahwit) access being negotiated by IOM with ExU.

#### **Next Steps:**

- Complete Baseline assessment and prioritize by Oct 2017.
- Engage with other Clusters (National & Sub National) on Site support, minimum package of assistance, further capacity building in Site management

# Shelter/NFI/CCCM Cluster IDP Hosting Site Capacity Response Strategy:

- Prioritize IDP Sites and advocate for Inter Cluster support for Site Coordination & Site Focal Points (SFP) support.
- Site Management learning gap analysis to prioritize capacity building support SFP (ExU) and NNGOs
- Advocacy with CCCM Global Partners (UNHCR, NRC, DRC, ACTED, IOM) to deploy qualified CCCM staff as resource.
- Engage with OCHA YHPF and other funding instruments to be more flexible on the selection of Partners, especially NNGOs.
   Promote CCCM integrated approaches in the YHPF 2017 second allocation and the YHRP/HNO 2018 to get political buy in and visibility.
- Advocate with Donor Organizations (ECHO/DFID) to fund CCCM expert positions in Partner organizations focus on international staff in national NGO's to build organizational capacity and resource for Shelter/NFI/CCCM Cluster.
- Provide Site Management and coordination support to Dahadh IDP spontaneous settlement in Khamir district, Amarn Governorate to demonstrate the effectiveness of the concept and identify lessons learned.

## Funding priorities – HPF 2017 Second Allocation HRP/HNO 2018

### 1. Shelter Minimum Package

- People in outdoor and informal settings and people in in abandoned, unfinished or public buildings receive basic shelter materials (tents, tarpaulins, plastic sheeting, poles, ropes)
- People in abandoned, unfinished or public buildings receive sealing off kits (plastic sheeting, wood, tools, nails, ropes, clear sheet)
- Advocacy for immediate access to safety & safe location of IDP hosting Sites
- Facilitating access to services by carrying out mapping exercises, information sessions and referrals
- Establish a clear site management structure- considering Gender balance
- Establish systems for IDPs to access services within the site
- Establish of Site Representative Committee

#### 2. NFI Minimum Package

- Basic/minimum NFIs are provided to people in in outdoor and other informal settings and to people in in abandoned, unfinished or public buildings, and in "formal managed" sites and settlements.
- People in abandoned, unfinished or public buildings receive sealing off kits
- People in outdoor and other informal settings, in abandoned, unfinished or public buildings, and in "formal managed" sites and settlements
  receive basic NFI support in terms of replenishment of acclimatisation items blankets/ clothing, kerosene distributions, through cash/
  vouchers.

# Funding priorities – HPF 2017 Second Allocation HRP/HNO 2018

### 3. IDP Hosting Sites (CCCM) minimum package

- Site monitoring carried out and minimum services are ensured and/or advocated for
- Demographic information disaggregated by sex and age to an agreed reporting cycle is regularly collected
- Site management support (to the authorities) structure minimally in place through roving teams
- All IDPs in displacement sites have access to shelter
- All IDPs in displacement sites have access to at least one NFI distribution in the last three months
- IDP population has access to potable water supply within walking distance
- Number and percentage of displacement sites where IDP population has access to WASH infrastructure.
- Number and percentage of displacement sites with food/nutrition needs where at least one food distribution has taken place within the past month
- Number and percentage of displacement sites that have functioning health services within walking distance that IDP populations can attend
