1. UNOCHA Update	ACTION	
Topic – Overview of the OCHA cluster transition strategy.	Who	When
·		
It remains understood that the government has and will continue to lead cluster		
coordination efforts.		
Clusters have been solidifying how they will transition and hand over their		
responsibilities to the government. There is not one transition model.		
OCHA Gorkha, Chautara, and Charikot hubs will officially be closed on Sep. 30.		
OCHA is not leaving. There will be maintained capacity in Ktm.		
On August 13 th there was a reflections workshop with all pre-eq cluster leads.		
This was to plan transition back towards former cluster systems.		
Each district will have a unique transition process to match their circumstances.		
Some clusters and districts have already transitioned back to former structures.		
Clusters have defined their transition strategy. They have been collected by		
UNOCHA and it will feed into operations post September 30 th . UNDP and the		
Early-Recovery Cluster are also planning the transition process.		
Ministry of Home Affairs (MOHA) has requested that I/NGOs remain engaged		
with the pre-existing organizations in Nepal.		
Cluster performance assessments will begin in September in 3 parts:		
OCHA internal review		
HCT review		
 Government and international partner review 		
Next steps:		
 OCHA is developing a one-page guidance note for government and NGO 		
partner capacity building.		
 Transition planning matrix will be consolidated. 		
 Guidance for district transition plans will be offered. 		
 Handing over to the district level government bodies. 		
Comment: The Shelter Cluster's needs will likely continue long beyond the		
timeframe of the other clusters. There is concern that the SC will end up		
responsible for much of the larger coordination needs, especially after OCHA		
reduces its role. Also, since the SC in all country responses does not have a single		
standard government agency to handover to it is often a more complex process.

3. Eastern Hub Update	ACTION	
Topic – Information on Okhaldhunga and Ramechhap was shared.	Who	When
Okhaldhunga		
Francesco, the eastern hub coordinator, walked through 4 Okhaldhunga		
VDCs to get a sense of the damage and needs. These areas were selected		
based on feedback from the district NRCS chapter.		
 High level damage was seen in under 10% of buildings. 		
 Medium damage (significant cracks) was seen in 20%. 		
Minor damage occurred in the majority of HHs.		
These are unofficial damage categories and the percentages are a rough		
feel from the walk through.		
Some HHs with no damage were seen. These could be good guides for		
reconstruction.		
Temporary shelters were made mostly of bamboo and plastic sheeting.		
There was little evidence of humanitarian intervention.		
There is a large sense of fear. Families with potentially habitable homes		
are living in temporary shelters with concern about more earthquakes.		
Access constraints		
 Access through Ramechhap is the easiest way to enter. 		
 3 access points are available: 2 in Ramechhap. 1 from Sindhuli. 		
 Some VDCs can be accessed by jeep or tractor. Many more are 		
only accessible by foot.		
 Landslides have blocked many roads. 		
Ramechhap		
NRCS has helped to expand on the winterization needs in Ramechhap.		
8 VDCs were identified that sit above the snow line.		
CDO document showed that 43,910 HHs have received the 15,000 NPR		
cash grant. This was blanket coverage, not based on damage data.		
Tarpaulin coverage in Ramechhap is still lacking. 5 underserved VDCs		
were identified and shared. Agencies should asses these VDCs before		
beginning distributions.

	This covered over 1680 HHs (over 120 per district).	
	 The first assessment produced 14 district factsheets, which can 	
	be found on the SC or REACH websites. There is also a longer	
	report with narrative available on both websites.	
•	2 nd assessment will occur in September-October.	
	 This will be a longitudinal research study to feed into the 	
	national strategic planning and monitoring.	
	It will cover assistance, shelter conditions, damage levels, and	
	reconstruction/recovery needs and actions. o Indicators will be comparable with the other cluster	
	assessments.	
•	The next TWG for assessments will be on Wednesday at 9:30am.

61 responses in total. 35 were INGOs; 12 were local/national NGOs.		
Many agencies have responded with current activity in trainings, technical		
assistance, and cash/market work.		
Based on the response received, we estimate there is over 200 million USD in		
confirmed funding for reconstruction and recovery.

301 international technical staff		
422 engineers registered with the NEC (Nepal engineering counsel)

6. UNHAS Survey Results	ACTION	
Topic – Results of the SC UNHAS Survey were shared.	Who	When
36 agencies responded. Of those, 100% reported that UNHAS closure would		
negatively impact their activity.		
81,200 HHs affected by this.		
• \$498,905 USD in increased costs.		
66-day delay on activity.		
The need for maintained UNHAS activity is very great.		
On Friday there will be a presentation to donors for UNHAS funding. Agencies		
need to contact their cluster needs to get them to advocate on their behalf.		
These results were just based on shelter activities. They do not account for other		
sectors.		
7. Gender Mainstreaming in Shelter/NFI – GenCap Advisor	ACTION	
Topic – Overview of how to effectively mainstream gender needs in Nepal.	Who	When
The GenCap advisor, working in coordination with the gender working group,		
represents the combined gender effort of many clusters and agencies.		
The flash appeal has a strong commitment towards gender needs.		
In the past month, 9 gender indicators have been created. In order to track		
these, it is important for all agencies to collect disaggregated data. Sex and age		
are both crucial to this process.		
When looking at shelter, it is important to understand the specific needs for		
gender related safety and security. There is already basic guidance available on		
this topic.
