3.3 **PODR:** has raised a request for new displaced population to Bulbul Timbisco from Ed Elfursan and Kubum resulted from last inter agency assessment done December 2013

**NCA:** shared 6HHs of fire outbreak affected in Fiha Jaw village as result of its internal agency assessment during reporting week.

GFO: reported internal assessment mission during last week covered several area in Niteaga locality, 1355 HHs are identified to be most vulnerable within whole locality.

NCA: provided SE/NFIs assistances to 6HHs fire affected in Fiha Jaw village from own pipe line stock as rapid response internally.

## 3.5 Population movements update

**OCHA**: reported that unconfirmed 183 HHs from Um Alkhirat to Gereida comps,15-25 HHs from Yassin to Kalma comps due to harassment in area,100HHs from west east Tullus to Tullus town on background of some tense between Misirya and Slamat tribal conflict.

Moreover there are some refuges have settled in Al gabal area arrived from central Africa
