NEED ANALYSIS

- **2021 HNO:** 5.88 million people are in need for shelter support across the county, out of which, 2.9 million are within the coverage of the Syria Hub. Two thirds of the people in need have shelter severity scores of 3 or above.
- **2022 HNO:** The Shelter & NFI sectors have completed the analysis plan and associated questionnaire which forms part of the MSNA. A total of 7 questions (and associated indicators) are designed to identify shelter needs in terms of shelter type, form of occupancy, damage level, adequacy, and privacy.

RESPONSE

- **2021 HRP:** Shelter partners submitted their 2021 proposals through the online tool targeting 1.2M i.e. 40% of the total shelter target at WoS level. The total funding requirement for the Syria Hub is USD 99M.
- **Resource Mobilization:** The SHF 1st Standard Allocation was launched in mid-June with a focus on under-served locations. The SNFI allocation is USD 5M.
- **Sub-national Coordination:** The Shelter and NFI sectors conducted a full week training for the sub-national focal points on coordination values, mechanisms, tools and reporting, in addition to sharing best practices from the field.
- **Cross-Sector Coordination:** The shelter sector is coordinating with both WASH and Early Recovery to ensure clear delineation of roles in terms of infrastructure repair and to deliver a comprehensive coordinated response to people in need.

GAPS / CHALLENGES

- Significant economic decline coupled with price fluctuation has resulted in a decreasing scope and/or target of shelter projects.
- Diminishing coping capacities of both IDPs and host communities as well as limited financial resources of government and sector partners are leading to an increase in shelter needs.
- COVID-19 related restrictions and emerging need to provide higher standards for spaces and WASH facilities increase the cost and duration for shelter projects.
- Lengthy processes continue for obtaining official approval for shelter projects and associated beneficiary lists.
- Opportunities for systematic field-based data collection remain limited due to access restrictions, resulting in incomplete needs analysis in some areas.

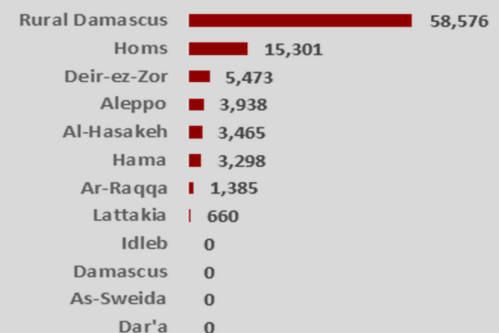

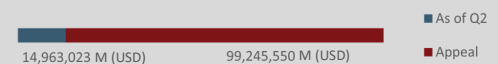


7.6 % OF 1.2 M TARGETED PIN BY SYRIA HUB

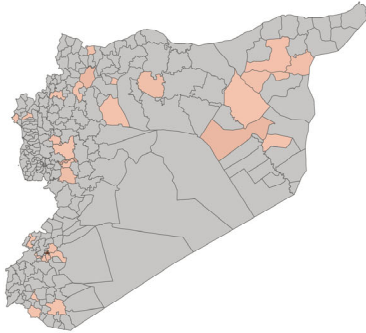

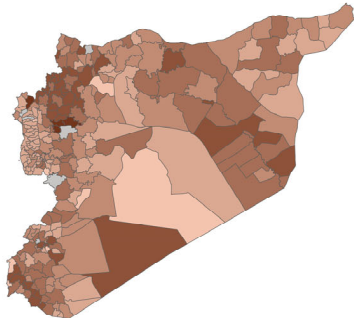

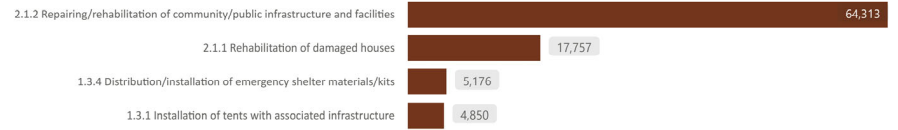


Shelter Sector Severity by sub district

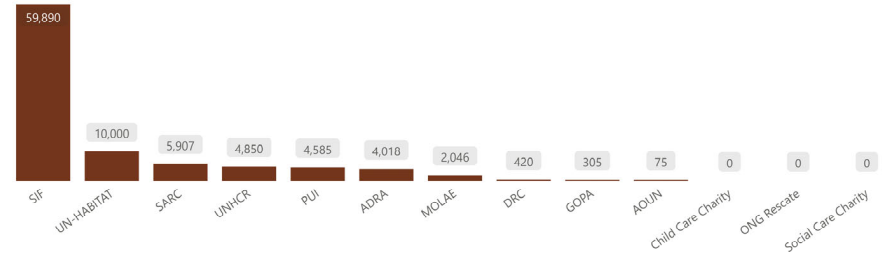

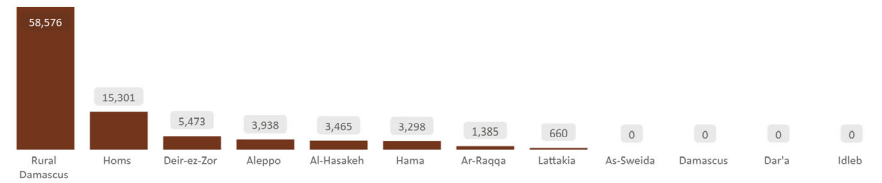
BENEFICIARIES REACHED PER TYPE OF SUPPORT
