Introductions	<ul> <li>The meeting was opened by CCCM/NFI Cluster coordinator (CC), Jade Chakowa.</li> <li>CC led roundtable introductions and presented the agenda.</li> <li>As agreed in the Cluster meeting on 26 April, the meeting aims to discuss capacities for both the recovery response to damaged caused by storm since 18 April.</li> </ul>	•
Updating Emergency Shelter Response Matrix	<ul> <li>Inputs from MRCS, UNHCR, Metta and NRC on the shelter needs as a result of the storm were added to the Shelter Response Matrix. The focus was on clarifying the emergency shelter needs, such as emergency tents and tarpaulin.</li> <li>Shelter needs are based on information from Cluster members, and no verification by the Cluster lead agency has been conducted.</li> </ul>	CC to continue updating and sharing Emergency Shelter Response Matrix.
Agency Response Plans / Capacity	<ul> <li>Metta can cover procurement and distribution of tarpaulin to Zai Aung, Maga Yang, Pajau and Haku Shau.</li> <li>MRCS confirmed the availability of 2000 tarpaulins and tents in Myitkyina. MRCS can distribute tarpaulins, shelter toolkits and nylon rope to Shi Jai and Loije Lisu if needed.</li> </ul>	•





	<ul> <li>OCHA proposed looking at cash as a possible modality. It was noted that cash would not be feasible for the emergency in the majority of affected camps due to their location in NGCA, market access and material availability. Cash could be explored as a modality for care and maintenance in parallel with the emergency response.</li> <li>IRRC provided the Cluster with a detailed list of zinc sheet required.</li> <li>UNHCR confirmed the immediate availability of 19 new tents and 11 used tents in Myitkyina. Additional stocks can be requested from Yangon but require a minimum of 7 days for transportation.</li> <li>OCHA highlighted the use of MHF funds for the response, noting that the timeframe for the allocation process can be long.</li> </ul>	
Response Plans for Tents	<ul> <li>2 options identified: UNHCR provides emergency tents or INGOs to release funds procurement in China.</li> <li>UNHCR committed to providing tents to respond to the needs identified by NGOs. Support would be needed for transportation to affected camps.</li> <li>OCHA shared that WFP will be travelling to Border Post 8 and may be able to transport emergency tents.</li> <li>MRCS could support by providing tents if their involvement is accepted by the IRRC.</li> </ul>	<ul> <li>UNHCR to provide 30 tents from UNHCR Myitkyina stock.</li> <li>National Cluster Coordinator to request tent stock balance from UNHCR Yangon.</li> <li>KBC and KMSS to explore transportation options.</li> <li>CC to discuss transportation of tents to BP8 with WFP.</li> <li>OCHA to discuss MRCS access with IRRC.</li> </ul>
Response Plans for Tarpaulins	<ul> <li>Agreed to for Metta to proceed with procurement of tarpaulin from China, which will be completed within 3 days. Metta to distribute to Zai Aung, Maga Yang, Pajau, Haku Shau. Metta will liaise with IRRC on the possibility of distribution in Hpare and Border Post 6.</li> <li>Metta proposed to procure 30 tents for Hpare if they can be distributed by KBC. UNHCR agreed to look into covering the transportation costs.</li> <li>If additional funds are required, CC will inform DRC.</li> <li>MRCS can contribute funds for assistance to 5000 families and communicate with the Chinese Red Cross, if access provided by IRRC.</li> </ul>	<ul> <li>Metta to procure and distribute tarpaulin to Zai Aung, Maga Yang. Pajau and Haku Shau.</li> <li>Metta to confirm possibility to distribute to BP6 and Hpare.</li> <li>UNHCR to confirm transportation costs for Hpare.</li> </ul>
