2	<p>Current displacement and outstanding CCCM/Shelter/NFI needs</p> <ul style="list-style-type: none"> <li>• Tanai: 328 HHs <ul style="list-style-type: none"> <li>○ Metta: 14,000 MMK/HH for NFIs (4 church compounds Tanai)</li> <li>○ MRCS: 255 HHs (Tarp, blanket, Mosq. Net.)</li> <li>○ OUTSTANDING NEED: <ul style="list-style-type: none"> <li>▪ NFIs for Church of Christ (34 HHs) + cooking utensils for all locations (to be confirmed)</li> <li>▪ Bedding and emergency shelter</li> </ul> </li> </ul> </li> <li>• Sadung <ul style="list-style-type: none"> <li>○ SI: Emergency shelter kits for 85 HHs. NFI kits for 92 HHs (Feb 2017)</li> <li>○ OUTSTANDING NEED: <ul style="list-style-type: none"> <li>▪ IDPs are requesting 81 emergency shelter kits.</li> </ul> </li> </ul> </li> </ul>	
3	<p>Access issues</p> <ul style="list-style-type: none"> <li>• MRCS NFIs were blocked on the road for Tanai</li> <li>• KMSS NFIs were blocked on the road for BP 8 and 6 at Sadung checkpoint</li> <li>• Shalom NFIs were blocked on the road for Chipwi</li> </ul> <p>ICRC asked for TA for Tanai from State Government but it was not granted (Ministry of Border Affair)</p>	
4	<p>Camp Profiling</p> <ul style="list-style-type: none"> <li>• Data collected has been completed and is currently with UNHCR IM department for data cleaning and validation.</li> <li>• Launch is expected to be end of July/start Aug</li> <li>• Workshops will be held in Myitkyina, Bhamo and Lashio to ensure input from all sectors to enable collection of relevant data for all partners across sectors.</li> </ul>	

	<ul style="list-style-type: none"> <li>• Timing should be adjusted to inform planning for future programming (launch should be before deadline for proposals for donors)</li> </ul>	
5	<p>Agency updates:</p> <ul style="list-style-type: none"> <li>• CCCM <ul style="list-style-type: none"> <li>○ Shalom raised a concern of stopping CCCM activities in camps under 10 HHs <ul style="list-style-type: none"> <li>▪ In order to cover the needs of as many locations as possible, UNHCR CCCM Unit has suggested to make adjustments to CRC, FP and size of camps that should be covered with CCCM activities. Stopping CCCM activities does not mean stopping other humanitarian interventions in the location.</li> </ul> </li> </ul> </li> <li>• NFI: <ul style="list-style-type: none"> <li>○ Capacity of SI: 200 HHs (stocked in Bhamo but can cover all of Kachin)</li> </ul> </li> <li>• Shelter: <ul style="list-style-type: none"> <li>○ ICRC has received a request from CMC in Je yang Kha camp for renovation of shelter. DRC did a shelter assessment in December 2016, but so far no shelter project planned. KMSS-M is the designated CMA and has recently assessed the need for renovation to be as high as 740 shelters in need of care and maintenance. The cluster has requested shelter projects in Je Yang Kha among other camps to be considered for the next round of MHF.</li> <li>○ ICRC: Constructing 15 shelters in Gaday Lei Pyin, Hpakant (KBC is CMA)</li> <li>○ Capacity of SI: 100 emergency shelter kits (Stocked in Bhamo but can cover all of Kachin)</li> </ul> </li> <li>• Winter NFIs <ul style="list-style-type: none"> <li>○ Plan international: 3095 kits planned for NGCA: children sets (blankets, clothes and gloves). Locally procured and distributed through partners.</li> </ul> </li> </ul>
