Displacement due to Conflict

► Background

Some 2,520 households were reported to be newly displaced in Otash and Kass IDP camps, South Darfur as a result of the on-going conflict between the government and SLA armed forces in Jebel Marra, ES/NFI assistance was provided to 2,323 households following verification by partners RDN & AOCD.

► Background

190 households in various locations in South Darfur were reported to have been displaced due to the destruction of their shelters by fire. ES/NFI assistance was provided to 174 households following verification by partner JMCO and PODR.

► Background

Assessments for renewal distributions among protracted IDP households continued in Nyala Locality. During the reporting period, 125 vulnerable households in Safia, identified through protection vulnerability criteria for People with Special Needs (PSNs) were assisted with renewal NFIs from the Common Pipeline by partner NCA.

Some 601 households were reported to have been displaced to Zalingei IDP camps as a result of the ongoing conflict between the government and SLA armed forces in Jebel Mara. ES/NFI assistance was provided to 576 households following verification.

► Background

Some 1650 families were reported to have returned from Mornei IDP camp in West Darfur to new Rongatas village in Central Darfur. A joint UNHCR/NCA mission was undertaken to verify the reported returnee households. ES/NFI assistance was provided to 1,634 households following verification. Partner TGH reported the return of 1300 refugee HHs from CAR to Muradaf in central Darfur. A joint UNHCR/TGH verification mission was undertaken and ES/NFI assistance was provided to 1300 households following verification.

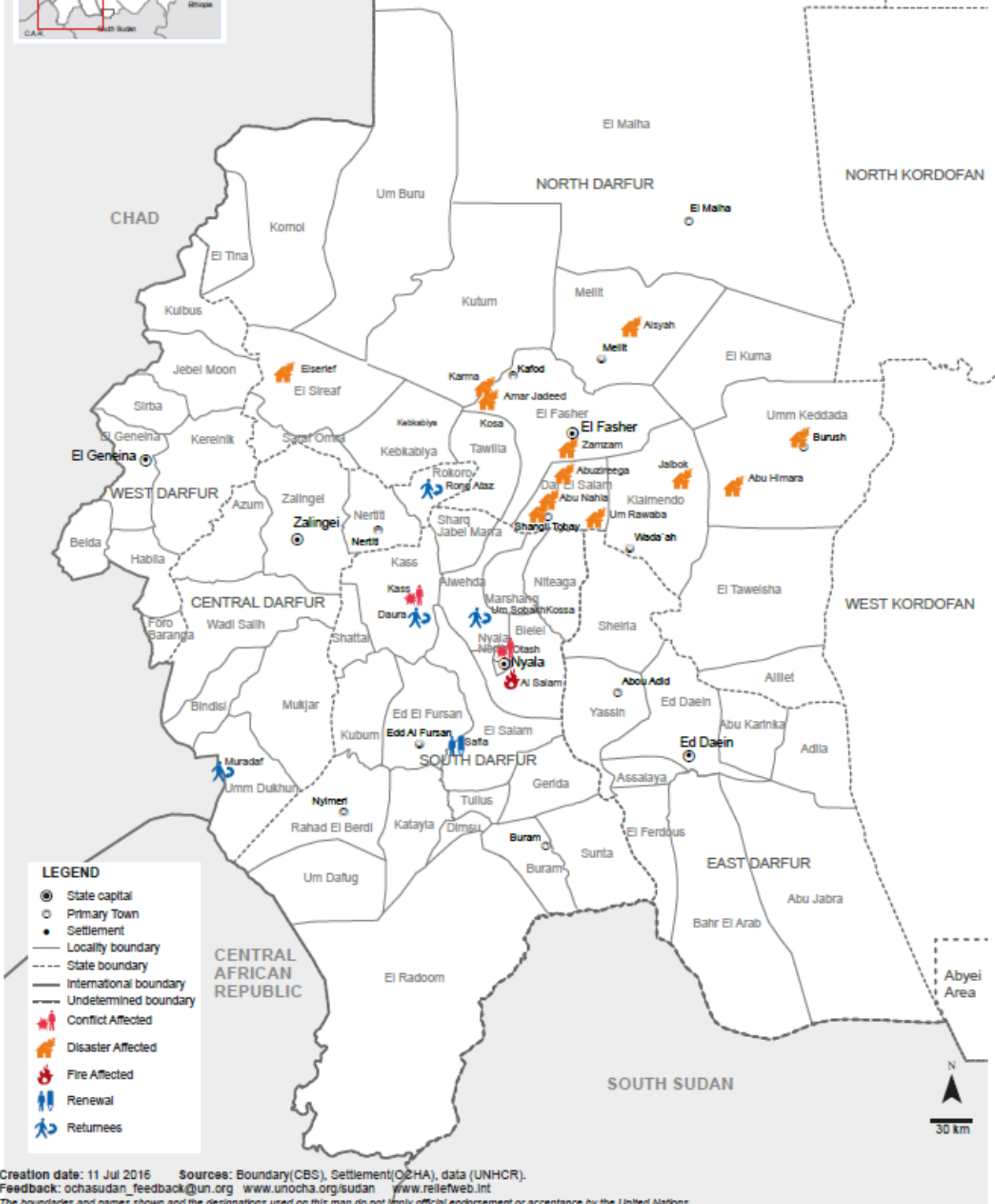
